On February 27, 2001, the United States Securities and Exchange Commission commenced a lawsuit in the U.S. District Court for the Southern District of Indiana against certain individuals, namely John E. Brinker, Jr., and Gary J. Bentz, as well as a number of companies they own or control.

This letter is to inform you that the undersigned has been appointed the Receiver for the following companies: Alpha Advantage II, Inc., Castrock Consulting, LLC, Eleven-Eighty Five, LP, Guardian First Limited, Inc. (Both the Nevada and Grenada Corporations), Wellington Bank and Trust, LTD., Wellington Capital Holdings, LTD., INC., Wellington Capital Holdings, LTD., Wellington International Investments, Inc., Wellington First International Investments, Inc., and all subsequently numbered Wellington International Investments, Inc. entities. Generally these companies are referred to as the "Wellington Companies." According to information received by the Receiver, you may be a trade creditor of one or more of the Wellington Companies.

The Receiver's investigation has concluded that any distribution to the Receivership creditors is unlikely. If there is a distribution, claim forms will be sent to all creditors involved and a claims process will commence.
